It is to inform that your establishment stands notified under the provision of Gazette Notification No. SO(Dev-I)/PESSI/7-120/2003 dated 18-07-2003 published on 23-07-2003 and covered under the purview of Social Security Scheme with effect from date of notification i.e. 23.07.2003 **or** from date of start of your business / project whichever is later. **Registration No. 3-82-4609** is being allotted to your establishment / firm for the purpose of all kinds of future correspondence and remittance of Social Security Contribution this office.

You are accordingly directed to deposit the Social Security Contribution @ 6% of monthly wage in respect of all such Employees mentioned in the schedule of provincial Employees Social Security Contribution rules with effect from actual date of functioning of your establishment and get all the Employees registered with this office immediately enabling them to avail Medical Care facilities and other such benefits being provided by PESSI under Sections **35,36,37,38,39,40,41,42,43,44 and 45** of Social Security Ordinance, 1965. The payment is required to be made by 20th of each month through crossed cheque / draft/ pay order/online in the name of "The Commissioner Punjab Employee's Social Security" & remitted at Directorate of Social Security, 70-A, Small Industries Estate, Multan Road, Bahawalpur. In case of default in the payment of Social Security Contribution, an increase at the rate of Rs. 0.50 per 100 per day shall be charged under Section 23 (i) of the said Ordinance. Necessary forms relating to payment of Social Security Contribution and registration of workers/employees **i.e.R-2 & C-1 Schedules** etc are enclosed herewith. Violation of any provision of above Ordinance is a criminal offence under section 66 of the Ordinance *ibid*. You are advised to fill the enclosed forms and return the same duly signed & stamp immediately to this office.
